## FIRST AMENDMENT TO TERM CONTRACT FOR VENDING MACHINE SERVICES (RFP-603691-19/TLR)

THIS FIRST AMENDMENT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 2021, and is to that certain Agreement made and entered into on the 20<sup>th</sup> day of April, 2020, between COMPASS GROUP USA, INC. d/b/a CANTEEN VENDING SERVICES, whose address is 28100 U.S. Highway 19 N., Suite 307, Clearwater, Florida 33791, in this Amendment referred to as "VENDOR", and SEMINOLE COUNTY, a charter county and political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 E. 1<sup>st</sup> Street, Sanford, Florida 32771, in this Amendment referred to as "COUNTY".

## WITNESSETH:

WHEREAS, VENDOR and COUNTY entered into the above referenced Agreement on April 28, 2020, to provide vending services; and

WHEREAS, the parties desire to amend the Agreement in order to update VENDOR's address for revise snack pricing and to enable both parties to continue to enjoy the mutual benefits the Agreement provides; and

**WHEREAS**, Section 25 of the Agreement provides that any amendments will be valid only when expressed in writing and duly signed by the parties,

**NOW, THEREFORE,** in consideration of the mutual understandings and agreements contained in this Amendment, the parties agree to amend the Agreement as follows:

1. Section 24 of the Agreement is amended to read as follows:

**Section 24. Notices.** Any notice delivered with respect to this Agreement must be in writing and will be deemed to be delivered (whether or not actually received) when (i) hand-delivered to the persons designated below, or (ii) when deposited in the United States Mail, postage prepaid, certified mail, return-receipt requested, addressed to the person at the address for the party

Agreement remain in full force and effect for the term of the Agreement.
