Comment: Only one of the team members provided by the Proposer has broadband experience. This may be sufficient but it is not clear. The rest of the team does have extensive experience working with public sector

Evaluator: Rebecca Hammock

Comment: Highly qualified large firm. Diverse company with all the needed disciplines to perform the scope of work. Proposal provides only four resumes for the key personnel. Based in Louisiana with offices in Texas,

Alabama, Arkansas, and New York. Has grant management experience.

Comment: HGA will conduct a broadband assessment that includes a needs assessment, infrastructure inventory, assessment of county policy, and gap analysis to develop and implement a strategy for a Broadband Plan.

Comment: Discussed Work Breakdown Structure (WBS). Mentioned Seminole Business Park, which we don't have, so not really sure they get it.

Evaluator: James Garoutsos

Comment: Proposer responded with a reasonable plan. While they may have a good understanding of our request, they did not document a point for point response

Evaluator: Rebecca Hammock

Comment: Has a fairly good understanding of the project, however, price point may be an indication that their project understanding is too narrow in scope.

Evaluator: Meloney Koontz

Comment: The work plan includes a review of current trends in telecommunications technologies and an assessment of what will be required to develop additional broadband infrastructure. Review wireless technologies (5G and 6G, 60GHZ and other frequency bands, the other technical enhancements for satellite-based broadband service, and advances via optical fiber routes. Inventory Seminole County fiber assets. Conduct a residential market analysis and a broadband assessment of Seminole county's regulatory environment for zoning and permitting, utility requirements, local and national building codes, environmental impact, local ordinances, and any other regulatory items. Conduct a gap analysis related to each area in the work plan. The timeline is seven weeks from the start to the final report.

Comment: 7 week schedule - seems too short to gather data on available ISPs and come up with a plan. Surveys and outreach discussed, but again 7 weeks is barely enough time to get surveys back I would think. Only firm to really discuss innovations though - RouteNAV, VistaTRAK and GIS.

Comment: Proposer provided a workplan that may be sufficient but is lightly documented and appears to have a rather aggressive timeline. Proposer cited a number of products that could improve the outcomes of this assessment.

Comment: Utilizes a specialized software program VistaTrak to have all information in one place as well as an application called RouteNav to help formulate the best business decisions. Very short timetable, only 7 weeks.

Quick results but may not address all issues desired by the County.

Comment: Off-shoot of IBM - mentioned many times. No subconsultants. Based out of NYC. No specific names of team or staff working on the project given. No years exp for staff; only 30 years of company.

Comment: While proposer claimed the team provided would have years of experience, the actually team that would support Seminole County was not provided.

Evaluator: Rebecca Hammock

Comment: Company appears to be well qualified but no individual resumes or information provided on staff members or team.

Criteria: Project Understanding

Evaluator: Meloney Koontz

Comment: As a systems integrator, Kyndryl provides technology and carrier-agnostic recommendations based on our needs.

Evaluator: Charles Wetzel

Comment: Not sure they understand the magnitude of data collection on ISP providers.

Evaluator: James Garoutsos

Comment: Proposer responded with a reasonable plan though it was light on details. While their understanding of our request may be sufficient, they did not document a point for point response.

Evaluator: Rebecca Hammock

Comment: Kyndryl understands the basic project but makes no mention of ARPA and only appears to provide a proposal for the initial assessment.

Criteria: Approach & Innovation

Evaluator: Meloney Koontz

Comment: The broadband assessment is expected to take three months. At the conclusion of the assessment, Kyndryl will provide a detailed report outlining the as-is conditions of broadband within the county, evaluation of available services which could be expanded or extended to cover underserved and unserved regions of the county, and identify potential new services which could be introduced. Described the process the Kyndryl team will use to complete the assessment.

Comment: 3 months to complete - may be too short. Kick-off meeting and 2 days on-site. No innovations listed.

Comment: Very basic approach outlined without a lot detail or innovative approaches provided.

Comment: Provided four entities that were past projects: A Florida County Government with an assessment and design of a fiber-based GifE WAN for the entire school district with 241 schools, colleges, and 93 charter schools., a Florida Energy Utility -performed an assessment and design of the utility's operational and information technologies and designed 700 substations, 120 corporate office locations, etc. Ohio School District-performed an assessment and design of community-centric fiber-based GigE WAN for the entire school district with more than 68 schools. Tennessee School District - Performed an assessment and design of a school-wide fiber-based ATM and eventual GigE Wan for the school district with 214 schools.

Plans to perform interviews with private retail providers to obtain information on current network expansion and upgrade plans.

Committee. Well thought-out and thorough approach including collecting and analyzing cellular data. Approach also includes mapping existing fiber and broadband equipment.

One of the subconsultants is a local company (located in Orlando) so will be familiar with Seminole County.
