We voted against the MSBU program and on our form it was designated that "NO" meant we would not participate in and would not pay the imposed \$971 Capital Assessment fee, causing a lean on our property for 15 years. Now that votes have been tallied and the MSBU program has received enough votes, we are being told we need to pay? This is wrong. We said we would not pay and were clear on our ballot that we were against the MSBU program from the beginning. We should not be forced to pay for a park that we will never use nor be made to cause a lien on our property we do not want and did not ask for. Are you not taking into account the ones who said "NO" which meant they were not supporting the MSBU program, financially? Thank you for taking time to communicate your objections to the estimated assessments for the Seminole County former golf course property stabilization. Your mailed objection will be filed as a public record in association with the Public Hearing scheduled for Dec 14.

The purpose and intent of the MSBU Petition is to gage community support whether "In favor" or "Against" the potential creation of an MSBU. Upon creation and subsequent adoption by the Board of County Commissioners, an assessment boundary which encompassed homes receiving benefit for the property stabilization at the former golf course property in Deer Run was created with the criterion being all homes within a .5-mile radius for inclusion. The MSBU Program is permitted to seek board approval once the required level of community support (65%) is achieved. Be advised the Board of County Commissioner's has the final authority to create an MSBU and will have a copy of your original objection on file.
