A RESOLUTION PROVIDING FOR THE NAMING OF A STREET FROM UNNAMED TO SKYRAIDER COURT IN SANFORD, FLORIDA 32773;

AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, under the authority contained in Sections 336.05, Florida Statute (2018) and

Chapter 90 of the Seminole County Land Development Code, the Seminole County Board of

County Commissioners may name and rename streets and roads; and

WHEREAS, the Seminole County Board of County Commissioners has deemed it

expedient to name an unnamed public right-of-way to Skyraider Court for consistency throughout

County records; and

WHEREAS, the unnamed public right-of-way is located within unincorporated Seminole

County jurisdiction; and

WHEREAS, the public roadway and adjacent pond to the south was altered during the

East Lake Mary Boulevard road construction, between 2003 and 2004, which created this segment;

and

WHEREAS, during an Emergency Operations exercise, it was requested that this be

named, since this segment is used for staging during an emergency; and

WHEREAS, the GIS Situs Address Layer and Street Centerline currently reflect no name;

and

WHEREAS, the street segment to be named is located north of Seminole County Board

of County Commissioners owned Parcel No. 07-20-31-5LR-0000-005A, located off of East Lake

Mary Boulevard, between Ohio Avenue and Red Cleveland, Sanford, Florida 32773; and

**Section 1.** The County right-of-way located south of Seminole County Tax Parcel No. 08-20-31-300-0290-0000 and north of Seminole County Tax Parcel No. 07-20-31-5LR-0000-005A and intersecting with East Lake Mary Boulevard is hereby named **Skyraider Court**.

**Section 2.** This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.
