BEGIN ON THE WEST LINE OF SECTION 28, TOWNSHIP 21 SOUTH, RANGE 30 EAST, AT A POINT 6.09 FEET NO2°57'40"W, OF THE SW CORNER OF SAID SECTION 28; THENCE RUN N87°11'40"E, A DISTANCE OF 620.09 FEET; THENCE RUN N87°33'20"E, A DISTANCE OF 363.56 FEET TO THE BEGINNING OF A CURVE CONCAVE TO THE SOUTHERLY AND HAVING A RADIUS OF 34377.47 FEET; THENCE RUN EASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 00°43'17" A DISTANCE OF 432.83 FEET TO THE END OF SAID CURVE; THENCE RUN N88°16'37"E, A DISTANCE OF 901.33 FEET TO THE BEGINNING OF A CURVE CONCAVE TO THE NORTHERLY AND HAVING A RADIUS OF 6875.49 FEET; THENCE RUN EASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 03°52'14" A DISTANCE OF 464.47 FEET TO THE END OF SAID CURVE AND THE BEGINNING OF A REVERSE CURVE, CONCAVE TO THE SOUTHERLY AND HAVING A RADIUS OF 5151.10 FEET; THENCE RUN EASTERLY ALONG THE ARC OF SAID CURVE THROUGH A CENTRAL ANGLE OF 04°47'36" A DISTANCE OF 430.94 FEET TO THE END OF SAID CURVE; THENCE RUN N89°11'59"E, A DISTANCE OF 736.56 FEET TO INTERSECT THE SOUTH LINE OF SAID SECTION 28; THENCE RUN N87°58'35"E, A DISTANCE OF 1324.49 FEET TO THE SE CORNER OF SAID SECTION 28 FOR THE END OF THE DESCRIBED LINE.
