

**RESOLUTION**

of the

**SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS**

**A RESOLUTION PROVIDING FOR RENAMING OF AN APARTMENT COMPLEX FROM “AVESTA AT WINTER PARK” TO “SAPPHIRE WINTER PARK” IN WINTER PARK, FLORIDA 32792; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, under the authority contained in Seminole County Land Development Code, Chapter 90, Section 90.10(f), the Seminole County Board of County Commissioners may rename an apartment complex; and

**WHEREAS**, the Seminole County Board of County Commissioners has deemed it expedient to rename the apartment complex known as Avesta at Winter Park to Sapphire Winter Park for consistency throughout County records; and

**WHEREAS**, Avesta at Winter Park is located within unincorporated Seminole County jurisdiction; and

**WHEREAS**, after the County sent notification of the needed requirements as outlined in Section 90.10(f), the owner has replied with the required information, requesting the County to change the apartment complex name; and

**WHEREAS**, a review of Google Street view from January 2019, displays the apartment complex signs have been changed to reflect “Sapphire Winter Park”; and

**WHEREAS**, Land Development Code, Chapter 90, Section 90.10(f) states there is a fee, however, the Board of County Commissioners have not adopted a facility name change fee per the adopted fee resolution; and

**WHEREAS**, adoption of this Resolution will therefore not result in any address changes for the affected property owners; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:**

**Section 1.** The apartment complex located at 1743 Semoran North Circle, Winter Park, Florida 32792, Parcel No.: 33-21-30-300-0010-0000, is renamed **SAPPHIRE WINTER PARK**.

**Section 2.** This Resolution will become effective upon adoption by the Seminole County Board of County Commissioners.
